

## Unruly Parties & Underage Drinking

People who begin drinking before age 15 are 4 times more likely to develop alcohol dependence than those who start drinking at 21 years of age.<sup>3</sup>

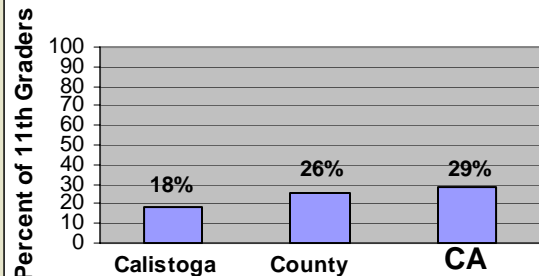
## WHAT'S THE PROBLEM?

According to the 2008 California Healthy Kids Survey, underage drinking is a problem in Calistoga.

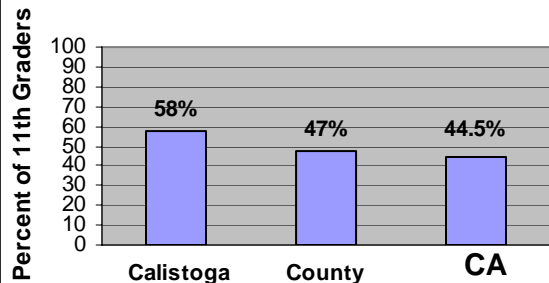
Among 11th graders in Calistoga:<sup>1</sup>

- 36% report drinking alcohol in the past 30 days
- 28% report that they have driven after drinking alcohol (themselves or by a friend)
- 61% have used alcohol by the age of 14

Percent of 11th Graders Who Have Been Drunk or Sick From Drinking Alcohol

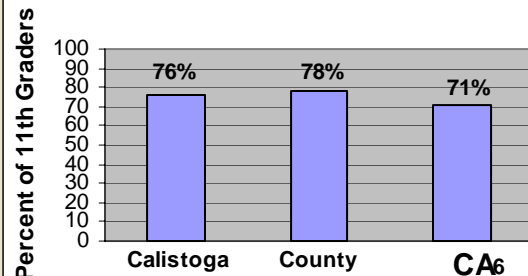


## IT'S EASY FOR YOUTH TO GET ALCOHOL

Most 11th Graders in Calistoga report that it is **fairly easy** or **very easy** to obtain alcohol.

Most underage drinkers in Calistoga report that they usually get their alcohol at **parties** or at **home**.

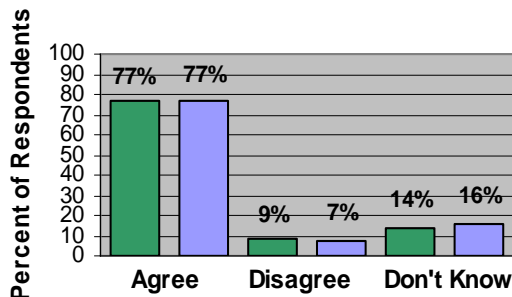
# WHAT DOES MY COMMUNITY THINK?

## Underage Drinking is a Problem in My Community

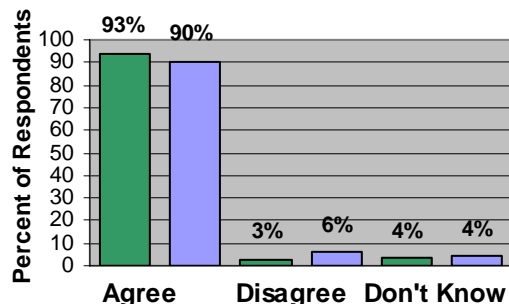


Green=Calistoga; Purple=Napa County

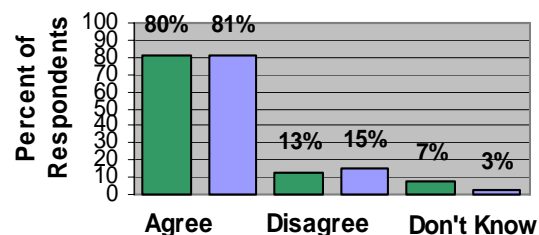
